Warning of Risk

I agree to waive, relinquish, release, and forever discharge BARKLEY'S, and their officers, employees, and agents, as well as the property owners from any and all claims or causes of action for damages, injury, loss, liability, or expenses that I may now have or which may accrue hereafter to me or any other person claiming through my or on my behalf and arising out of, connected with, or in any way associated with use of this park.
